- Frequently updated syllabus with help of industry and academic experts as per the changing need of industry.
- GTU organizes the International Experience Program (IEP) at Laurentian University, Canada for B.Pharm students where, the students learn about advanced research and subject content by the foreign professors.
- M. Pharm students have to study five patents as a part of his/her dissertation work and have to prepare "Patent Search Analysis Report (PSAR)"
- M. Pharm students have been evaluated at centralized level examination twice in a year for their dissertation work, wherein experts from nationally repute institutes like CDRI, CSIR, NIPER, SRMC, JSS, NMIMS, ICT, BHU and like institutes are invited along with Industrial Experts and International Experts from LU, Canada and UWS, Australia.
- For creating the industry orientation and developing industry ready skills the students of a Finishing School model is developed.
- GTU also have the strong presence and support system for IPR where, students are made aware and supported for patent filing.
- GTU curriculum is having large pool of Elective subjects. As of now, about 16 electives
